

CONDITIONS OF ENTRY

General

1. Information on how to enter the **Australian Caravan+RV Win a Motorhome Convoy Tour to Canada/Alaska** promotion (**Promotion**) and prizes form part of these conditions of entry.
2. By participating in this Promotion, you will be deemed to have: (a) accepted these terms and conditions; and (b) expressly consented to our use of your personal information for the purpose of the Privacy Act, Spam Act, other related privacy legislation and for marketing.
3. The promoter is NRMA Open Road Pty Ltd (**Promoter**) ABN 91 000 026 844 of 9A York St, Sydney, NSW 2000.
4. The Promotion commences at 9am am (AEST) on 12 October 2011 and entries close at 5.30 pm (AEST) on 29 April 2012 (**Promotional Period**).
5. Entry is open to Australian residents only aged 21 years and over.

How to Enter

6. Entrants must subscribe to Caravan+RV magazine for 1, 2 or 3 years (**Subscription**) or have received a Subscription as a gift. Entry is subject to a valid credit card payment or, if payment is made by cheque, the cheque must be cleared for payment within the Promotional Period.
